Programme Promotes National Cause

ignal Year of Environ It is said that the year 2009 will be remembered as the year the world found an answer to climate change. The world community is looking to leaders for an effective common action plan to combat climate change during talks in Copenhagen in December this year. Similarly in Pakistan the current year has been declared as the 'National Year of Environment'. Led by the Ministry of Environment (MoE), efforts are underway at various levels to bring forth the environment as a priority agenda item in Pakistan's national development.

Pakistan's world record breaking planting of 541,176 trees, overseen by the MoE is one in a series of wide ranging initiatives forming part of the commemorations of the year of Environment in Pakistan.

Being a significant partner in conservation in the country, WWF - Pakistan is putting all possible efforts in this national campaign to promote the cause of environmental conservation. In this regard, the initiatives taken by the Indus for All Programme are worth mentioning. The Programme has carried out a wide array of activities ranging from public awareness campaigns to media engagements, plantation days and development of communication and education materials.

As part of the Year of Environment celebrations the Programme organized World Wetlands Day on 2 February in Thatta, World Water Day on 22 March in Sanghar, Earth Day on 22 April in Keti Bunder, Biodiversity Day on 22 May in Sanghar and Shaheed Benazirabad (formerly Nawabshah) Districts and World Environment Day in Sanghar. In addition, to raise public awareness on global environmental concerns like climate change these events were instrumental in highlighting the issues of the Indus Ecoregion particularly the crisis of freshwater in Sindh. The Programme on various occasions during these events engaged media to draw attention of policy makers and other stakeholders.

Owing to the Programme's outreach efforts the Indus Delta and associated natural resource issues remained focus of media, academia, public representatives and policy makers. The National Assembly's Standing Committee on Environment has constituted a sub-committee on the Indus Delta to take concrete steps to conserve threatened mangrove ecosystem of the Delta. We look forward to ever greater recognition of environmental stresses and increased collective efforts to address such stresses.

Programme Highlights

Friends of Indus Forum Visits Pai Forest

The 6th meeting of the Friends of Indus Forum was held on 4 April 2009 at the Chambers of Commerce and Industry's Hall, Hyderabad. Prior to the meeting the members visited Pai Forest. They were briefed on the conservation challenges threatening the forest and initiatives undertaken by the Indus for All Programme. Members were informed that the Forum's registration process has been initiated, while a position paper on water requirements downstream Kotri barrage has been developed. This paper will be shared with the members for their comments prior to printing. At Hyderabad, a presentation was made to the Hyderabad Chamber of Commerce and Industry (HCCI) to sensitize the business community about the situation of the Indus River and Indus Delta.

Building Capacity of District Governments

A three-day training workshop on Environmental Impact Assessment (EIA) was organized for District Government officials between 18-20 June 2009. The training was conducted by National Environmental Consultants (NEC). During the workshop Indus for All Programme was introduced by the Programme Coordinator. The training covered various aspects of EIA including core concepts of EIA, stakeholders and their roles, EIA processes and contents, scope of EIA reports and critical evaluation of the EIA reports. The participants were given copies of EIA of the RBOD-II for study and were taken to the site to witness the impacts of the mega drain project on local communities and ecology. Two documentaries on environmental issues in Sindh were also screened. The training was attended by 18 district government officials from Thatta, Sanghar and Shaheed Benazira-bad (formerly Nawabshah) Districts, whereas three representatives from academia and four staff members from site offices

Another two-day training workshop on Environmental Indicators was organized for District Government officials from 26-27 June, 2009. The training covered various aspects of environmental indicators including an introduction to environmental indicators, development of indicator lists, framework for environmental indicators and sets of core and key environmental indicators. The training was attended by 18 district government officials from Thatta, Sanghar and Shaheed Benazirabad Districts, two representatives from academia, one from Environmental Protection Agency and four staff members from site offices.

Environmental Education through Spellathon

More than twenty thousand students participated in a competition called Spellathon-2009, organized by WWF Pakistan for school children of the Indus Ecoregion. Spellathon is part of WWF- Pakistan's awareness raising campaign designed to raise environmental awareness amongst schoolchildren and their families. The Programme staff engages selected school teachers, students and parents in studying various environmental themes provided in an information pack. Selected students then undergo a spelling test based on the information provided in the pack. For each correct spelling they earn points and are encouraged to contribute a certain amount against points earned for nature conservation. At the end of the activity, students receive gift packs made of various products depicting natural environment. Introduced in 1996, the Spellathon has accessed millions of school children and their parents in major cities of the country.

In terms of the Programme's policy outlook, we have been focusing on our poverty-environment linkages research and on introducing the indicators proposed by this study into government policy and planning documents. For instance, in January 2009, the Ministry of Finance released its second Poverty-Reduction Strategy Paper (PRSP-II). The PRSP-II focuses on national poverty reduction; is to be holistically implemented by different ministries and departments; and refers to the environment as a cross-cutting thematic issue. The Programme has expressed concern over the limited representation of poverty-environment indicators in the PRSP-II and the paucity of environmental data that is being reported. The PRSP Secretariat, the primary administrative and monitoring unit of the PRSP-II process, has responded positively to these concerns and has expressed a strong interest in adapting the Programme's povertyenvironment research as a source of both data and a starting point for revising environmental indicators.

Other avenues of fruitful interaction with both the federal and provincial government are: integration of poverty-environment linkages in the second phase of the Medium Term Development Framework (MTDF); development of a poverty-environment sensitive sector paper; implementation of National Resource Management (NRM) and Livelihood Development Plans (LDP) in Programme sites; and revision of the Sindh Forest and Wildlife Acts in collaboration with the Sindh Forests and Wildlife Department.

The Poverty-Environment Watch

PE Indicators and PE Linkages Study - What to Expect?

The forthcoming poverty-environmental indicators and linkages study is primarily tailored for application by Programme staff. As the study analyzes data from the Programme's 2008 socio-economic and ecological baselines, the prescriptions emerging from it are at the village and household level. This makes it uniquely suited for refining interventions up to 2012.

In the case of PE linkages, as early results from the study reveal, prescriptions emerge from a two stage process. First, the study empirically tests a series of relevant and hypothesized mechanisms through which the underlying causes of environmental degradation are transformed into actions that degrade the environment. For example, the study points to a possible inverse relationship at Keti Bunder between poverty (as measured by average monthly income of households) and environment (the percentage of households engaged in fishing).

That is, for a point in time, namely 2008, data bears out that as income increases the percentage of households dependent on fishing decreases in villages covered by the Programme's baseline, except for Keti Bunder and Haji Aleem Sholani villages. The study examines four other linkages at Keti relating to waterborne diseases, incomes from fishing, open space toilets and thatched roofs. A total of 20 linkages are examined across all sites, with many linkages rejected on account of issues relating to the relevance or appropriateness of data.

Second, the study produces prescriptions that not only rely on examination of empirically tested PE linkages but, importantly, on intensive consultations. Focus group meetings were held at all four Programme sites, also key informant meetings, as well as meetings with experienced Programme staff. The consultations were particularly useful. For example, as concerns thatched roofs, interestingly the ubiquitous presence of katcha housing (thatched huts/roofs) is explained by humid weather conditions in the delta area and bears no relationship to varying levels of household income. Let us look at one example of a prescription. In the case of water borne diseases, we learn that disease occurrence is high in all three income classes constructed by the study, that the source of drinking water is a common one, and that staff should review interventions (again, usefully, in specified villages) with a view to addressing declining real income as related medical expenses rise and a decline in productivity/earnings as restricted activity and bed illness days are experienced. What about PE indicators? A total of 14' indicators are constructed and tested in the Programme's study, a minimum of 3 per site. These are intended to enable responses to patterns of deterioration ahead of major breaches to natural biological cycles of environmental assets at Chotiari, Pai, Keti Bunder, and Keenjhar. Again, a thorough process of testing based on datasets and consultations was followed. It should be pointed out that relevant regional and international experience, literature reviews, and case study examination informs the process of identifying indicators and proposing ways of applying them. Activities of the Programme up to 2012 are dependent on the proposed indicators. For example, an indicator for income and harvesting of fish at Chotiari is intended to supplement implementation of Chotiari's livelihood plan for which work commences in July 2009.

The seminar was attended by Mr. Askari Taqvi, Minister for Environment and Alternative Energy, and Mir Hussain Ali, Secretary for Environment and Alternative Energy. During his presentation Mr. Rab Nawaz gave examples of entrepreneurship from community managed trophy hunting in Kaigah Valley, community managed eco-tourism by the Kakapir community at Sandspit and the Better Management Agriculture Practices across Punjab and Sindh.

Environmental Education: Training Master Trainers

The Indus for All Programme, WWF-Pakistan organized Master Trainers Training in Environmental Education on 3-7 May 2009 in Hyderabad with the Collaboration of District Thatta's Education Department. Twenty two teachers from government and private schools including 8 women and 14 man participated in the training. The participants included Principals, high and junior school teachers. Mr. Qamar Shahid Siddiqui was the lead facilitator; while Mr. Shahid Hussain Mughal and Mr. Muhammad Zafar Khan facilitated the training.

The training was inaugurated by Ms. Farheen Mughal, Member of Provincial Assembly (MPA), Sindh. Mr. Nasir Ali Panhwar, Programme Coordinator, Mr. A. M. Aslam Jarwar, Site Manager, Keenjhar Lake and Mr. Zahid Hussain Jalbani, Site Manager, Keti Bunder were also present.

An interesting component of the training was the field visit to Miani Forest where participants observed the biodiversity of the forest and learnt of the various pressures affecting its ecosystem. In the last day participants made Action Plans for the Environmental Education Programme of their schools. Certificates were also distributed among the participants.

Keenjhar Festival

The Indus for All Programme actively supported Keenjhar Festival organized by the Sindh Tourism Development Corporation (STDC). On this occasion, the call was made through a resolution initiated by the Programme and its partner CBO Jhol Marri Welfare and Development Organization. The resolution was signed by the Minister Culture and Tourism, Ms. Sassui Palijo, MPA, Dr. Sikandar Mendhro, MPA, Ms. Rukhsana Shah, Secretary Culture and Tourism, Mr. Shams Jafrani, DCO Thatta, Mr. Manzoor Ahmed Shaikh, Programme Coordinator, Indus for All Programme, Mr. Nasir Ali Panhwar, Site Manager, Mr. Zahid Jalbani and others. The resolution said that steps should be taken to prevent the dumping of industrial effluents from Kotri, Nooriabad and the steel mill project in Jhimpir. Small mash nets should be banned for fishing and illegal bird hunting should be stopped. Moreover, the Karachi Water and Sewerage Board and Nooriabad Industrial Area should allocate a budget for the development of communities around the Lake. The resolution confirms the status of Keenjhar Lake as a wild life sanctuary and Ramsar site.

Speaking on the occasion the Minster for Culture said that Keenjhar will be developed to provide eco-tourism opportunities to the residents of Sindh. Mr. Nasir Ali Panhwar described conservation and information centre proposed at the lake to create awareness about its rich ecology. A boat race and earthen pitcher race was organized for the event. The Minister for Culture and Tourism and Minister for Social Welfare and others gave cash prize to the winners.

Workshop for Resource User Groups at Keenjhar Lake

The PIU at Keenjhar Lake with support from Keenjhar Maroara Welfare and Development Organization, Amir Pir and Jhole Mari Welfare and Development Organization organized a two day workshop at Jhimpir from 5-6 June 2009. The workshop was designed to sensitize the two main resource user groups of Keenjhar lake, (mat makers and quarries) so that they can better manage the natural resources of their area. Twenty eight participants attended the workshop of which 20 were mat makers while the remaining were quarriers. Mr. Jahangir Durrani, Natural Resource Management Officer, Indus for All Programme, Keenjhar Lake was the lead facilitator. A manual in Sindhi was developed for the participants, which included many activities for both user groups.

The training clarified the key terms, and described: the evolution of advocacy and rights based approaches; environmental rights; environmental protection agencies; the Devolution Plan; and social and advocacy movements. In his concluding session remarks the Chairman of the Pakistan Fisher folk Forum, Mr. Mohammad Ali Shah, said that the struggle for rights can be initiated from any platform. However, public support is essential for the success of any movement. The Programme's Coordinator, Mr. Nasir Ali Panhwar, agreed that lobbying and advocacy play a vital role in conservation and the aim of the training was to build the advocacy capacity of communities. Dr Allah Nawaz Samoo, Mr. Suleman G. Abro and Mr. Zafar Junejo addressed the participants.

International Earth Day was celebrated on 22 April 2009 at The Citizens Foundation (TCF) School in village Haji Noor Kinnat. Nearly 250 participants including: school teachers, children, community representatives and journalists from various print and electronic media were in attendance. Three Solar energy panels and one hybrid system have been successfully installed at four villages: Gilli Sholani, Haji Mamoo Dablo, Cheer Dablo and Kharyon of Khober and Hajmaro Creeks, Keti Bunder Tehsil. One wind turbine of hybrid system has yet to be delivered; however village electrification is complete.

Farmers Field School Training at Chotiari

The Chotiari Reservoir team successfully completed a wheat crop training session in Mehran Farmer Field School, Chotiari. 25 farmers registered at the school while 90 percent completed their training course. Mr. Habib Baig a Farmer Field School expert was deputed by the Department of Agriculture, government of Sindh as a subject specialist while Mr. Dilber Kerio and Mr. Liaquat Ali Mallah shared facilitation duties. The school was running with the collaboration of Chotiari Development Organization.

Installation of Biogas Units in Villages of Chotiari Reservoir

A biogas unit has been installed at village Mohammad Hasan Hingoro near Paksri, Chotiari Reservoir. This was a joint venture by Indus for All Programme and Pakistan Council for Renewable Energy Technologies (PCRET). The intervention is a new technology for the area. The unit is operating successfully. Beneficiaries have experienced a reduced demand for fuel wood; and the unit has reduced indoor air pollution. Six more biogas plants are planned to be installed in different villages around Chotiari Reservoir by the end of quarter.

Vocational Centre Inaugurated
